



School Reopening Plan 2020-2021

Jefferson Local Schools

Tuesday, SEPT 8, 2020

School will start on Sept 8th, 2020.

The MS/HS complex will have 2 options to start: Option 1 will be Hybrid where students attend Brick & Mortar 2 days and 3 days of e-learning. Option 2 is 100% e-learning at home.

Norwood Elementary has 2 options to start: Option 1 is students attend Brick & Mortar 5 days a week and option 2 is 100% e-learning at home.

ENHANCED CLEANING PROTOCOL

Increased number of hand sanitizer devices.

Intense cleaning daily.

Safe, Effective cleaning products used throughout the day in the school/ classroom and on the bus.

COVID-19 Positive Protocol—Individuals will be quarantined for 14 days before returning to school. Contact tracing will be conducted by the Madison County Health Department.

Other Illnesses— Other illnesses by students/staff will be handled on a case by case basis with guidance from Madison County Public Health and the student/staff's physician.

SOME HEALTH & SAFETY PROTOCOLS

- ① **MASKS** - The Madison County Health Commissioner has ordered that students and staff will be required to wear a mask at all times, except while eating and drinking and during special cases. More details will be coming.
- ② **DIVIDED CLINIC LOCATIONS** - There will be an area for students displaying symptoms who are waiting to be picked up.
- ③ **SEATING Charts** - Seating charts will be required on buses and in classrooms. Siblings will be seated together on buses if possible.
- ④ **HAND WASHING** - Hand washing will be required throughout the day and hand sanitizer will be available throughout the schools.
- ⑤ **WATER BOTTLES** - Students will be allowed to carry water bottles. There will be some stations for students to fill their bottles. Water fountains cannot be used to get a drink of water.
- ⑥ **NO OUTSIDE FOOD DELIVERIES** - Deliveries will not be permitted into schools for students or staff during the school day.
- ⑦ **STAY HOME IF SICK** - Families should screen their children and keep them home if ill. Sick children will be directed immediately upon arrival to the school nurse if exhibiting symptoms.

CHANGES TO THE CLASSROOM/SCHOOL ENVIRONMENT

BACK-TO-SCHOOL EVENTS

- Family events will be primarily virtual.
- Student events will be held in-person requiring masks or social distancing with limited family participation in a highly structured environment.

CLASSROOMS

- Changes will be made to the classrooms to create more personal space. Students will face the same direction in classrooms as much as possible.
- Students will be required to immediately report to classrooms upon entering the school and not allowed to congregate in the hallways.
- Will minimize sharing of supplies
- K-5 music, art, and library will be held in student classrooms.

CAFETERIA ADJUSTMENTS

- No visitors for lunch.
- Adjustments made to serving lines
- Seating charts may be used in cafeteria if needed.
- K-2 students will eat in their room, 3-5 will be at 50% capacity, 6-12 will be spread out.

RECESS (K-5)

Individual classes will stay together at recess.

P.E.

Students will not be required to dress for P.E. to minimize locker room interactions. P.E. classes will also take place outdoors except during inclement weather.

FRONT OFFICES

Plexiglass barriers installed in front offices.

- No external field trips or convocations until further notice.
- Visitors/guests who must enter the school (ex: to pick up a student) will be limited to the main office and must wear a mask.
- Volunteers (during the day) will not be scheduled until further notice.
- Students participating in E-Learning may not be permitted to participate in some extra-curriculars.
- Facility usage limited to only those entities with whom Jefferson Local Schools has an approved written agreement.
- Eliminate perfect attendance incentives for staff and students for 2020-2021.
- If directed by the Madison County Health Department or the Ohio Department of Education, students may enter a hybrid schedule of in person learning and virtual learning or all virtual learning.
