ITEMS FOR DISCUSSION

Hometown Ticketing

Mr. Quinn likes the idea but is concerned with timing with an upcoming levy. It was noted that the levy will be on the ballot in November 2022, giving the District plenty of time to roll out the new product. Mrs. Duemmel stressed the importance of the Athletic Department educating the public on the change and app. It was noted that several other schools in the conference already has the program. There is a good chance that the District will have to go to an all online system in the near future regardless. The athletic department will be encouraged to offer senior passes or discounts. Hall of Fame guests will still be granted free entry into the games. Mr. Mullett will follow up with Mr. Daulton on some of the questions and concerns raised by the Board.

Food Service Bids/Discussion

Mr. Harper asked questions about current operations and the benefits of outsourcing.
